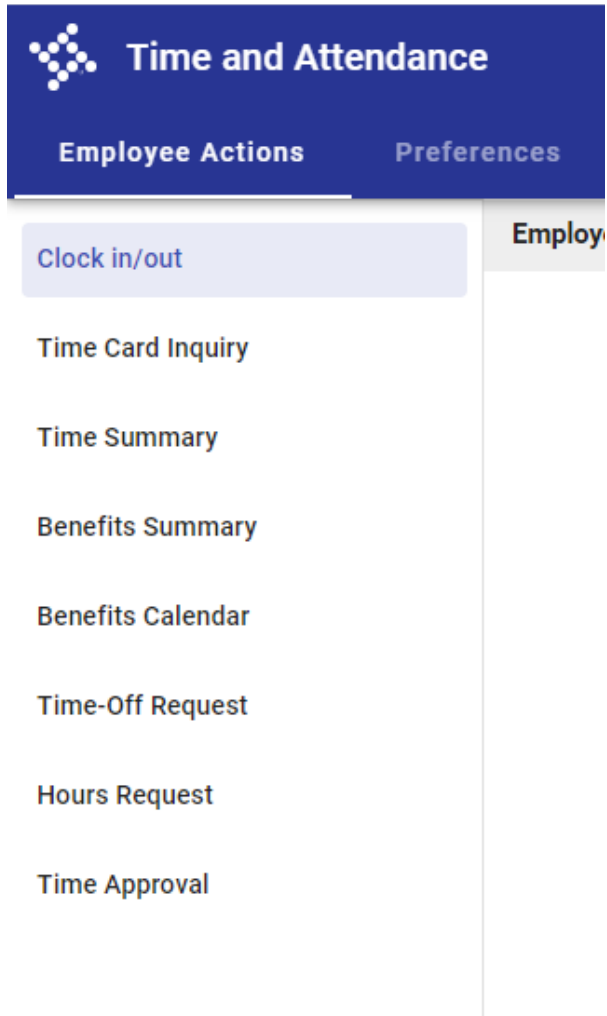


# Executime Employee Guide

## Menu Overview



**Clock In/Out** - The main screen where you record your time card entries throughout the day.

**Time Card Inquiry**- Where you can look at an overview of all the time keeping transactions in the current and previous pay period, as well as the overall history.

**Time Summary**- A detailed breakdown of the total hours collected in the current and previous pay period, as well as the overall history.

**Benefits Summary**- Where you can look at all Benefit Time available to you (i.e. Vacation, Sick, Holiday Worked, Comp). Furthermore, you can see a breakdown of Approved, Pending and Declined requests, as well as the overall history of your requests.

**Benefits Calendar**- A calendar view of any submitted and approved Benefit Time-Off requests.

**Time-Off Request**- Where you create, submit and review any Benefit Time-Off requests you have made.

**Hours Request**- Where you create, submit and review any special time requests for Jury Duty, Bereavement, After Hours, etc.

**Time Approval**- Where you review and approve your timesheet for the pay period. You can also view previous period time records and approvals.

## Logging In

Navigate to ExecuTime in **GOOGLE CHROME** or the **New Edge Browser**

Can be accessed by typing the following URL into the browser:

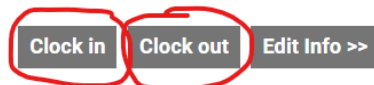

## Employee Clock In/Out

Click either Clock in or Clock out. If you discover that you have forgotten to clock out the previous day, click Clock out and then Clock in and inform your supervisor of the time you clocked out the previous day and they will correct your time for you.

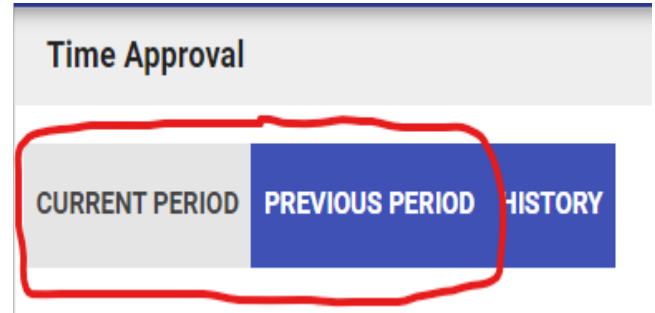

## Employee Time Approval

At the end of every pay period, each employee must review and approve their own time card. Employees will enter their own initials in the approval process. This ensures that the employee agrees the hours entered is accurate and complete. Once approved and submitted, the Supervisor will be notified (via email) that they need to approve the time card before it is sent to Payroll.



**IMPORTANT:** When approving your time, you must select the appropriate time period (Current Period or Previous Period) before submitting.

### Example 1: Current Pay Period

It's currently 4:30pm on a Friday, the last day of the two week pay period is Saturday. You've clocked out and will not be working any additional hours today. You would select 'Current Period' before submitting your time card.

### Example 2: Previous Pay Period

It's currently Monday morning, and the two week pay period just ended on the previous Saturday. You would select 'Previous Period' before submitting your time card.

To approve your time:

1. From the left menu, select 'Approve Time'.
2. Select 'Current Period' or 'Previous Period'.
3. Insert a check mark for the time entries you are submitting for approval.
4. Enter your initials.
5. Click the 'Approve and Submit' button.

When you approve a time card, your initials are automatically stored in the Employee column. The Supervisor column is not populated until a supervisor approves the time card. If any of these entries appear inaccurate, they can be changed by a supervisor through Employee Time Maintenance.

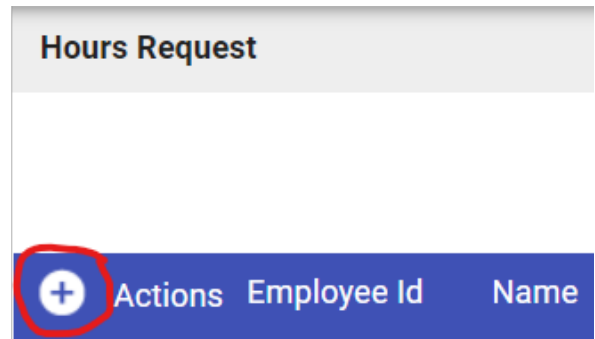
## Employee Time-Off Request

Time-Off Request manages your time-off requests. The Time-Off Request screen displays all information specific to each entry. This data includes the date and time the entry was created, the type of benefit requested, how many hours were requested for each entry, and whether the entry was approved, declined, or is still pending. Also, the program displays comments that were made at the time of the entry on this screen.

To complete a time-off request:

1. Click on 'Time-Off Request' tab from the left menu.
2. Click the Add button to display the Add Time-Off Request screen.
3. From the Benefit Type list, select the applicable pay code.
4. Enter the start and end dates for the hours request. If the duration entered exceeds the original date of the transaction, the program automatically populates the values into the next day or days depending on the length of the duration from the start date.
5. Enter the start time, if applicable, and enter the number of benefits hours to be used per day.
6. Enter a comment.
7. Click Save. The program displays the Hours Request Verification screen.
8. Click the Edit button to modify the request or the Delete button to remove it.

You can only edit or delete entries that have a pending status. A supervisor or administrator can edit a request that is approved or declined.

**Benefit Type** - This the pay type you are requesting.

## Employee Hours Request

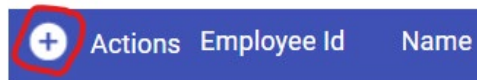
The Hours Request screen allows employees to request time that is not associated with accrued benefits, for example, overtime. All available pay codes are included in the type list. An Hours Request is typically sent *prior* to logging work time, but can be requested after the work time has occurred.

To complete an hours request:

9. Click on 'Hours Request' tab from the left menu.
10. Click the Add button to display the Add Request screen.
11. From the Type list, select the applicable pay code.
12. Enter the start and end dates for the hours request. If the duration entered exceeds the original date of the transaction, the program automatically populates the values into the next day or days depending on the length of the duration from the start date.
13. Enter the start time, if applicable, and enter the number of benefits hours to be used per day.
14. Enter a comment.
15. Click Save. The program displays the Hours Request Verification screen.
16. Click the Edit button to modify the request or the Delete button to remove it.

You can only edit or delete entries that have a pending status. A supervisor or administrator can edit a request that is approved or declined.

## View Benefits Balance

1. Login to ExecuTime.
2. Click on the "Benefits Summary" tab on the left side of the screen.
3. This screen will show you the balances of all available Benefit Time (Vacation, Comp Time). You can also view the Approved, Pending, Declined and Full History of any Benefit Time Requests by clicking the corresponding tab at the top of the page.
