District III: New Water Filtration System Will Disrupt Services

Cass Lake – Tribal Engineering has been working on getting a new water filtration system up and running. This is a 100 thousand dollar project funded through the EPA and managed by Johnny "Mac" Fairbanks in the engineering department at Leech Lake.

Water services will be intermittently interrupted during the week of February 23 for approximately 5-7 days as the new system comes online. The neighborhoods that will be affected are the Porcupine and Plantation areas near Mission in Cass Lake.

Mid-Year Financial Report From Michael J. Bongo, Secretary Treasurer Leech Lake Reservation

Greetings Fellow Leech Lake Band Members:

In my continuing effort to keep our Band members well informed about the financial condition of the Leech Lake Reservation I have prepared a mid-year financial report for our Band members review. For this report I will focus on what we commonly refer to as the Bands Direct Funding, i.e. our gaming revenue, state tax revenue and our hunting and fishing rights agreement with the state of Minnesota.

This fiscal year we have budgeted approximately \$15,726,000 in Direct Funding to the various programs and services of the Leech Lake Reservation. As a reminder the Leech Lake Reservation's fiscal year is July 1, to June 30, annually. Presently we are in the 8th month of our fiscal year and the magic number to remember is 62%, meaning that programs should have expended no more then 62% of their Direct Funding to date.

Initially I had sincerely hoped based upon our past efforts to improve the financial management of our Direct Funding budgets that I would have some positive and encouraging news to report. However I am sorry to inform you that I do not. Some of our Programs and Divisions continue to struggle with basic financial and budget management. Financial Report Cont. Page 14

While there we took in several meetings on Capital Hill with American Indian advocates and Representatives from Minnesota in order to keep the Leech Lake Band and our issues on the minds of our elected officials. There's an old saying that goes: the squeaky wheel gets the grease, and no where is this more accurate than in Washington D.C. when it comes to pushing agendas and trying to get things done here at home. Our voices being heard and faces being seen in Washington are crucial if we are to advance the Leech Lake cause. We need this constant lobbying effort on a national level and state level for that matter - so the elected officials who control the budgets for things like education, health care, resource management, culture/language preservation and a host of other issues see our leaders and listens to our leaders talking about issues like how Leech Lake needs a new hospital and a new Bug-O-Nay-Gee-Shig school. So when the time comes for new infrastructure funding they remember we were there talking about dilapidated schools and hospitals that have been on waiting lists for far too long.


In February of 2009, in his last State of Indian Nations address, NCAI President Joe A. Garcia highlighted

American Indian Gubernatorial Candidate Forum at BSU By Chris Haugene

Dr. Don Day, Director of the American Indian Resource Center, as well as the ACLU-MN, Greater MN Racial Justice Project, Wellstone Action Fund's Native American Leadership Program and Take Action Minnesota played host to an event for gubernatorial candidates in early January at Bemidji State University. The event was a first-time one-of-a-kind staging of candidates who have thrown their political hats into the ring and are trying to secure a DFL party nomination for Governor in this fall's election.

The evening began with an invocation by Leech Lake Elder Mike Smith and statements from each candidate and proceeded to several round table discussions where each candidate was asked questions and shared opinions on American Indian issues. State gaming played a controversial role as it always will in Indian Country and every candidate made statements on the issue.

Candidates in attendance were: Margaret Anderson Kelliher MN Speaker of the House District 60A, Tom Bakk MN Senator District 06, Mark Dayton Former US Senator, Matt Entenza Former MN House Minority Leader, Susan Gaertner Ramsey County Attorney, Steve Kelley Former MN State Senator, John Marty MN Senator District 54, Tom Rukavina MN House District 05A, R.T. Rybak Mayor of Minneapolis, and Paul Thissen MN House District 63A. We would like to encourage you to research these candidates online as each of them mentioned state gaming in their introductory remarks. Mark Dayton has since said that he will support state gaming if elected as Governor, so, while it is important to participate in events such as these it is also important to keep track of the candidates on the issues as the election nears so we see who is staying the course and who is waffling on the issues.

There were several local representatives in attendance including BSU Council of Indian Student Reps. Petra Neadeau, Anna Goldtooth, Andrea Goodwin, and Greg Wood who were setting an example for other Indian students whose engagement in politics is increasing with each election cycle. Chairman LaRose and District III Representative Whitebird as well as Executive Director Rob Aitken were in attendance from the Leech Lake Band of Ojibwe as well. Census = Money

The U.S. Constitution stipulates that every ten years we count everyone. Our community of American Indians is the nation's hardest population to count because of language and cultural barriers, travel issues, and a historic mistrust of government institutions and efforts such as these.

Counting everyone is critical; an accurate count means fair access to federal resources and fair representation in state legislatures and the United States Congress. But equally important, is that it determines the annual distribution to states and tribes, and our local communities i.e. children of more than \$400 billion in federal funds annually over the next 10 years. This money is based on census statistics and is used for everything from schools and roads to health care for lowincome residents, veterans and senior citizens.

Because the American Indian and Alaska Native population is relatively small, every Native person who is counted makes a huge difference in getting the right count which directly results in possible new funding for our areas. Recent studies have shown that for every person not counted, the local community loses more that \$1,000.00 annually. This is funding that goes toward every issue that we face from education, health care, resource management and child care to our elders the Tribal College and beyond.

US Census Needs about 1000 people in Bemidji area to fill jobs

The U. S. Census Bureau will hire about a thousand people in the Bemidji area and surrounding counties between now and spring. This strong economic shot in the arm is like having several factories open up in this area! Up to a total of approximately 1,000 people will be on staff during peak times.

Raising "Money-Smart" Children

Tribal Development Division will be working with the schools to teach Band member children about financial literacy. One of the first topics will be developing a savings plan.

Learn to Earn Money: Pay a weekly allowance in return for doing family chores like washing dishes, increase the amount as they get older. Help them become young entrepreneurs, i.e., babysitting, pet walking, painting, car washing, tutoring, chores done for neighbors and elders.

Learn to Set Goals: Have them write a wish list and make regular savings deposits toward something they want. Show them how long it will take if they save money every week so they can plan. Consider matching their savings, so they are motivated by reaching goal quicker. Try to let them learn the good feeling of earning something: kids take better care of things they buy with own money than if it is just given to them.

The Leech Lake Band of Ojibwe Learn to Save Money: Pay allowances in quarters instead of dollars: have them put 50 cents to savings, 50 cents to decide for themselves (spend or save more). Other sources of money include birthday gifts, pow-wow dance money, gift for grades and attendance, etc. Once a month go together and deposit their savings money with them. Credit unions and banks have special savings accounts for children which help them save.

> Learn to Enjoy Life without Spending: Help them find non-commercial places to be with friends. Plan family fun around no-cost activities, such as walks together, picnics, reading books aloud, playing board games, volunteering with seniors, getting books and movies from the library, gardening, inviting friends to a potluck party, starting a community garden plot, etc.

ORDER TO SHOW CAUSE

YOU (THE DEFENDANTS LISTED BELOW) ARE HEREBY ORDERED to appear before the Leech Lake Tribal Court and show cause why you should not be held in Contempt of Court for failure to pay court-ordered fines.

YOU ARE FURTHER NOTIFIED that pursuant to Leech Lake Traffic Code, Chapter, Section 304:

- 1. If you are found in Contempt of Court, you may be subject to an additional penalty not to exceed \$500.00, said penalty for contempt shall be in addition to any fines or other penalties previously assessed by this Court.





Veterans Upward Bound Program

Bemidji State University Veterans Upward Bound Program is a free grant funded TRIO program provided by the U.S. Department of Education. The program is designed to help veterans improve their academic skills so they can enroll in and be successful in college or other post secondary schools.

The Veterans Upward Bound (VUB) Program at Bemidji State University was recently funded for the next four years. The program is housed at Sanford Hall on the campus of BSU, however, we will help veterans prepare for any post-secondary institution they choose to attend.

VUB staff will assist veterans in improving and strengthening their academic skills through free tutoring and classes in areas of math, reading, English, science, computer basics and foreign languages. The staff will also help veterans by providing academic assessment testing, career exploration and guidance, applying for financial aid, all at no cost to the veterans. The hours and days of service are flexible, with veterans being able to study at their own pace and according to their own schedules.

Certain eligibility requirements are in place: Participants must meet the low income guidelines and/or be a potential first generation college student. Participants must have at least 180 days of active duty, unless released for medical reasons. Participants can also qualify if they had been a member of a reserve component called to active duty for a period of more than 30 days, or be a member of a reserve unit who served on active duty in support of a military operation on or after 09/11/01. All discharges qualify except dishonorable. The veteran must be a potential first generation college student (meaning that neither parent completed a four-year degree) OR meet low income guidelines.

IHS UPDATE:

Greetings! In the time of the namabini giizis

My name is Geeewaydenokwe, also known as Dr. Debra Meness the medical Director at Cass Lake Hospital. I am writing an update of IHS to be printed in the DeBahJiMon for the benefit of the Leech Lake community.

I arrived to Cass Lake a little more than one year ago. At that time the hospital had a shortage of doctors, no medical director, and a closed inpatient unit. I heard from many patients that there was much frustration about not being able to get an appointment in the clinic. I also heard about the long waits in the urgent care clinic and then seeing a parade of unknown temporary doctors once you were seen. There seemed to be two separate health systems on the reservation and a view that the IHS system was not responsive to the wishes of the community.

Then and now I see my role to restructure a health system that works closely in collaboration with the tribal health and social programs. We now work more together on community health issues. We openly share and dialogue and are creating a co-sharing rather than a competitive environment. We see our role at IHS as one in which we are here to shore up and strengthen the services at the tribal community clinics wherever needed. We are putting a children's dental clinic in the grade school. We have also hired a mental health therapist to help with people requesting counseling/therapy. Also to provide services not provided in the tribal clinics such as dental, optometry, podiatry, physical therapy Diabetes education, nutrition, on-site pharmacy, Lab, x-ray, mammography, ultra sound and audiology.

I am pleased to state that the inpatient unit is open and here to serve the needs of the people who need admission when they are to sick to be home. We are proud of the special attention and caring we can provide to community members who find themselves as patients in the ward of the hospital. We are also strive to make family visitors feel welcomed when they are visiting family who have been admitted to the hospital. Equally important we are proud to care for those Leech Lake people who are getting ready to journey to the next world and need medical help that a hospital can provide. As an initial recognized community effort we have signed an agreement with the Beltrami Hospice organization.

We have expanded services into the alternative medicine area. We now provide osteopathic manipulation, provided by Dr. Meness to adjust and align your body. This form of holistic medicine can help decrease pain, and improve mobility. It is for all ages. Karen Davis, Our mental health therapist/ counselor is incorporating flower essences that help with emotional pain and insecurities while getting talk therapy. If you are receiving talk therapy you can also get massages to help release emotional issues in the tissues of the body. We also now have acupuncture that is being provided in the clinic by Dr. Pittman.

We can continue to provide adult medicine for issues such as diabetes, hypertension, high cholesterol, thyroid issues and cancer, to name a few. We provide children and family medicine for health maintenance, immunizations, children's developmental issues, smoking cessation, sports physicals, Women's medicine for women's issues, and prenatal care. We have specialty medicine clinics for OB-GYN, nephrology (kidney/dialysis) and surgery clinics. We also have a three bed bay Emergency department and a busy urgent care, which are open 24/7 365 days a year.

We are working to establish a constant and regular medical staff that includes Dr. Salter, Dr. Guimaraes (accepting new patients), Dr Rith-Najarian, Dr. Heap-Chester(who works primarily in the tribal clinics), Tam Mahaffey(accepting new patients) and Sandra Erickson(accepting new patients), Amanda Pederson Nurse practitioners and Diane Bohn nurse midwife, Roxanne Johnson, nutritionist, Brian Hudson optometrist, Paul Schaffer, physical therapist and my self Dr. Meness. We have hired Dan Lilliquist, David Pecora and John Diab in the ER/Urgent Care, in addition to Deb Reynolds. We have hired Al Rudnick, podiatrist, and Karen Davis, LICSW . Dr. Wang and Dr. Pittman have returned and both are accepting new patients. Roleen Walgenbach has retired and returned to Iowa. In dental we have Dr. Larson, Dr. Boza and Dr. Ellis and Debra Salulka, dental hygienist.

Getting patients in for scheduled appointments continues to be a challenge for the patients as well as

scheduling by the hospital. We will keep working on this issue. Future plans include hiring a pediatrician. We plan to expand services for children and include children's mental health and osteopathic medicine for children.

We are striving to improve the work environment inside the hospital. We are encouraging good will and respect to each other and to translate a good attitude, service and respect always to the community of Leech Lake. Miigwech

the need for a summit with Tribal Leaders and Obama administration officials including the President himself. On November 5, 2009 newly elected President of the National Congress of American Indians and Garcia successor Jefferson Keel thanked President Obama for living up to his campaign promise for holding the White House Tribal Nations Conference.

It is through efforts such as these where the NCAI's constant presence in Washington D.C. helps carry American Indian issues to the forefront of the national political stage. And with Leech Lake's own voice represented within the NCAI in Eugene "Ribs" Whitebird, who was elected as a Regional Alternate Vice-President for the mid-western Tribes, there is an even more localized voicing of issues and concerns at the national level. So we are seeing promises being followed through with in President Keel attending and speaking for American Indian issues at the Tribal Nations Conference, and with Rep. Whitebird in his lobbying efforts in D.C. and voicing his opinions regarding Leech Lake and the issues we face here. Furthermore, we are seeing results from our efforts in Washington D.C. and not just through the NCAI – though their constant voice is crucial for Indian country we are now seeing issues pressed at a Congressional level.

In October of 2008, then senate hopeful Al Franken sat down with me during his campaign stop in Cass Lake and we discussed a couple of issues that concern Leech Lake. We talked about Indian issues being easily forgotten after being talked up on the campaign trail and we talked about the disrepair that our Bug-O-Nay-Gee-Shig school is in, as well as health care and natural resources, to name just a few. Mr. Franken looked at me towards the end of the interview and said that he couldn't wait to join the Senate and speak to these issues on a national level.

Dear Senator Franken:

It is with much sadness and regret that I find myself compelled to write this letter. For the past year and a half the Leech Lake Reservation Tribal Council has attempted to lobby Congress in hopes of securing funding for the construction of a new high school for our children.

In the process we have been patient but along the way we have continuously been given false information by the BIA/BIE. In numerous meeting with officials from the BIA/BIE we have been told that the Bug-O-Nay-Gee-Shig School was on this list or that list for new school replacement. In one meeting we were told that the Leech Lake Reservation was 3rd on what I can only characterize as a BIA/BIE mythical list and then suddenly 64th on another replacement list. As this has continued to play out our children are left to attend school in a substandard, rodent infested poll barn building.

As a people we have been asked to give up all that we are, our culture, our history, our language, our spirituality and religion and our land base. As reference I only need to mention the proposed Nelson Act Settlement as yet one more example of how the Leech Lake Reservation is again asked to bear the burden and make further sacrifices so that others may benefit.

During this time we are asked to break the cycle of poverty and dependency through education yet we are afforded just enough resources by the BIA/BIE to ensure our failure and our children are forced to attend school in an environment that can hardly be characterize as conducive to learning. Sadly as a nation and country we can appropriate billions of dollars annually on war and conflict while our children are left to continue to suffer in poverty and despair.

I am writing to appeal to your sense of fairness and justice by demanding as congressional representatives and fellow Minnesotans that the BIA/BIE discontinue the politic and favoritism and immediately appropriate the necessary resources for the construction of a new school and water treatment facility so that our children can be afforded the same opportunity as other children in America, to attend school in a safe, healthy, conducive learning environment.

I do not believe that such a request is out of line or unreasonable.

I continue to hope and pray that our efforts to address this unreasonable state of affairs will no longer fall upon deaf ears, and that someone will exhibit the leadership necessary to demand that the BIA/BIE be held accountable and up-hold its trust responsibility.

Lobbying Effort

During our meetings in Washington D.C. Leech Lake Band leaders met with Senator Franken's staff and mentioned some of these same issues (healthcare, education, and the Bug-O-Nay-Gee-Shig school's state of disrepair) to the good Senator's staff during their meeting. The very next day we sat in on a U.S. Senate Committee on Indian Affairs Hearing where Senator Franken mentioned Leech Lake, specifically the Bug-O-Nay-Gee-Shig school inquiring where our school was on the BIA's list of upgrades and new construction. Senator Franken asked Donald Laverdure - who works for the Bureau of Indian Affairs about this list of schools that are to be slated for repair or new construction. Mr. Laverdure mentioned that the list had been sent over to Mr. Franken's office, and after a brief consultation with some of his staff that were in attendance Senator Franken said that the list had not been delivered nor had his staffers seen any such documentation from the Bureau of Indian Affairs in recent days. Mr. Franken also mentioned this situation to Lillian Sparks who is President Obama's nomination for Commissioner of the Administration for Native Americans at the Department of Health and Human Services. "Transparency and accountability is very high on my list of priorities," said Miss Sparks. "Making sure information is accessible and readily available for our constituents, for our grants and for our Tribal governments is important. It will certainly be one of my top priorities, if confirmed, to make sure we have all of the information available to both members of Congress but also to our grantees and those that we serve. And I pledge to continue working with you and your Tribes to make sure that we receive the information needed with regards to where the schools are on the list."

It's one thing to hear words from candidates during the campaign, but to hear them echoed during a Senate hearing brings the political process to a place where we as a Band have been

looking to go for a long time. And those of us who supported Senator Franken should know that we made the right decision, and if you think you were wrong just ask yourself if Norm Coleman would be sitting on the Indian Affairs Committee speaking on behalf of Leech Lake and other Minnesota Bands. It's a nice surprise to see someone live up to their word in the world of professional politics, and as a part of society largely forgotten within the national view this should bring every American Indian in Minnesota a sense of achievement and hope with regard to Senator Franken. What is encouraging to me when I write about Senator Franken or NCAI President Keel or even our own leadership here at Leech Lake, is that I am not only hearing the promises being made, but I am seeing efforts from our elected leadership to try and bring our issues into places like the U.S. Senate and the National Congress of American Indians and to the State Legislature. It's happening; our leaders are striving to do the things they said they would in order to bring their vision of a better place home with them when they return from lobbying for us, be it on a Tribal, State, or Federal level. What is going to be difficult is to keep these officials on their toes by keeping Leech Lake's voice a constant presence in these places so we are remembered when the time comes to allocate funding for new hospitals and schools.

As the Secretary Treasurer it is my duty to continue to stress the need and importance for proper fiscal management. Unfortunately some of our programs continue to exhaust their Direct Funding budgets first as opposed to their Federal and State grants. When we manage our limited assets and resources in this manner it means that we have less resources for other Band member services such as increasing our tax re-bate which we have the capacity to do provided we do a better job of managing our Direct Funding resources.

That said our current Direct Funding by program year to date is as follows:

The bottom line is that this is simply unacceptable and we must begin to immediately improve the financial management of our various program budgets, if not then those responsible must be held accountable.

An additional concern is the fact that we spent approximately \$700,000 on the purchase of wild rice this past fall. While this was a direct benefit to our ricers and helped keep the price of rice up, it was a last minute decision by the Tribal Council and as such we did not plan or budget resources for this expenditure nor do we have a market for the resale of the rice. I characterize this as a ready, shoot, aim business philosophy. The end result is that we now have approximately 150,000 lbs. of finished rice and we are now scrambling to find suitable markets for resale in hopes of recapturing the \$700,000 that we expended on the purchase of the rice.

Recently I meet with fellow Leech Lake Band member Dennis Banks, who has contacts in Japan and has graciously offered to try an assist us in finding a short and hopefully long term market for the resale of this rice. However until such time as we resell the rice we have an additional revenue short fall of \$700,000 in our 2010 budget.

An additional revenue short fall has also been created through the sale of Seneca cigarettes. Essentially the State of MN alleges we are selling the Seneca cigarettes without collecting state taxes we are accused of being in violation of the State Sales Tax Agreement. This agreement has been in place since the mid 70s. Because of this situation the State of Minnesota has with-held the first two quarterly sale tax reimbursement payments to the Leech Lake Reservation for gas, cigarettes and

liquor which I estimate to be approximately \$562,000 for the first half of fiscal year 2010. To date we have generated approximately \$138,000 in tribal tax revenue from the sale of the Seneca cigarettes.

This is a highly complex issue and we are presently engaged in discussions, dialog and negotiations seeking both a political and administrative solutions. While I am hopeful that we can reach a settlement with the State of Minnesota on this issue and the tax rebate owed to the Reservation will ultimately be paid, I can not say this for certain and we could very well be headed for a long and protracted legal battle. As I stated earlier this is a very complex issue but is yet one more example of how we failed to fully analyze the potential impact of our decision. The end result is that we are now facing yet another revenue short fall exchanging approximately \$562,000 in guaranteed tax revenue for \$138,000 in cigarette tribal tax revenue.

As a result of these factors, over spending of our Direct Funding budget \$891,000, the unplanned purchase of \$700,000 worth of wild rice, and the temporary loss of the State Tax reimbursement payments of \$424,000 we have created a overall revenue shortfall of \$2,015,000 to date. We have five months left in the fiscal year and needless to say we must recapture this revenue by discontinuing the practice of over-spending our program budgets, find suitable markets for the resale of our wild rice, and resolve the standing tax dispute with the State of Minnesota.

The final item that I would like to cover is to provide you with an up-date on the number of Band members assisted on a monthly basis by the Secretary Treasurer's office. At the quarterly meeting last month Richard Johnson, raised the question as to why the Secretary Treasurer had two assistants, a very good question. To answer this question, unlike the other Tribal Council positions, the Secretary Treasurer position has a number of specific job duties to include safe guarding the Band's assets and resources, budget management, supervision of the Accounting Department, management of information released to the public, etc. and of course meeting with Band members when they have issues or problems. As part of my monthly report I have decided to also include Band member office visits.

For the month of January 2010, I had 104 office visits from Band members seeking assistance with various personal issues. 23 Band members were seeking employment of which we were able to assist 6 with gaining immediate employment at an average hourly wage of \$8.50 hour. The remaining 17 are either awaiting interviews or still searching for employment. We had 14 Band members seeking financial assistance with emergency health related issues and 71 Band members were seeking assist with various financial and utility related issues to included homelessness, housing issues, utility bills, and a host of other personal related issues. Overall I was able to assist 71 Band members requesting financial assistance ranging from \$300 to \$15.00.

As I stated I have two assistants, Nissa Peltier, deals with all of the employment related issues assisting with getting Band members interviews and following up on their progress and status. Tera Wilson is my Administrative Assistant and her primary duties and functions are maintaining my daily schedule, processing requests for financial assistance, taking and processing all Tribal Council minutes and resolutions, processing messages from Band members and in general trying to keep me organized and on target, which is no easy task. Any of our Band members who have stopped by my office clearly see that it is a very busy place and we try to do our very best to meet the needs of our Band members and make them our top priority. To the degree possible we try our very best to help our Band members provided they are making an attempt to help themselves. Our only limitation is limited resources and I do try and be as resourceful as I can be in finding resources

to help our Band members, however I would like to remind our Band members that in terms of limitations, each Council member has a limited budget of \$3,300 per month to provide emergency assistance to our Band members. Once we reach this budgeted amount our line items are shut down for the remainder of the month.

Because of the workload and the need to better serve our Band members is my primary reason for having two assistants.
