# IHS Offering Free Flu Shots: Protect yourself and others

Influenza season is here and it is time to get immunized. Influenza or the "flu" is a contagious respiratory illness caused by influenza viruses. It can cause mild to severe illness, and at times can lead to death. According to the Minnesota Department of Health (MDH), influenza activity in the state remains low, but is present with a sporadic spread across the state. It takes about two weeks from vaccination for antibodies to develop that protect against influenza virus infection so now is a perfect time to get vaccinated.

Symptoms of flu may include: a fever (usually high), headache, fatigue, dry cough, sore throat, runny or stuffy nose, and muscle aches. Flu viruses spread mainly from person to person through coughing or sneezing of people with influenza. It is possible to infect others beginning 1 day before symptoms develop and up to 5 days after becoming sick.

While it is not a 100% effective, the flu vaccine is still the single best way to prevent the flu. The "flu shot" is an inactivated vaccine (containing killed virus) that is given with a needle. It may also be given as a nasal spray. There are over a 1000 different flu viruses. Traditional flu vaccines made to protect against three different flu viruses (called "trivalent" vaccines) are available. In addition, this season flu vaccines made to protect against four different flu viruses (called "quadrivalent" vaccines) also are available.

You cannot get the flu from receiving the shot, but you may get symptoms that your body is making antibodies such as low grade fever and body aches. Flu vaccines will not protect against flu-like illnesses caused by non-influenza viruses.

It is also important to practice good health habits. CDC recommends that you stay home for at least 24 hours after your fever is gone. Stay away from others as much as possible to keep from making others sick. Continue to cover coughs and sneezes and wash hands even after you return to work. It is important to know that even if you don't have a fever, you may have flu and be contagious if you get flu symptoms. Antibiotics are NOT effective for viruses. If you are not extremely ill, it is better to stay at home than go to the clinic or hospital.

The CDC recommends an annual flu vaccine for everyone 6 months of age and older. People who are at higher risk from either getting the flu or having serious flu related complications include: health care workers, children between 6-59 months of age, pregnant women, people 50 years or older, people of any age with certain chronic medical conditions (examples: asthma, diabetes, COPD, heart disease), people who live in nursing homes and other long term care facilities, household contacts of persons at high risk of complication from flu, and/or of children less that 6 months of age.

You should not get vaccinated if you have a severe allergy to chicken eggs; have had a previous allergic reaction to an influenza vaccination; anyone who developed Guillain Barré syndrome (GBS) within 6 weeks of getting an influenza vaccine previously, and children less than 6 months of age. If you currently have a moderate or severe illness with a fever, you should wait to get vaccinated until your symptoms lessen. If you have questions about whether you should get a flu vaccine, consult your healthcare provider.

Please check with your local pharmacy or clinic for vaccine availability in your area. If you are eligible for the Cass Lake Indian Hospital, vaccine is available for all ages. You can come in as a walk-in basis or call your health care team for an appointment time if that works better for your schedule. Leech Lake Tribal Health clinics also still have vaccine available, but please call for clinics hours.

# Tribal Court Fines Going Unpaid, Consequences to Come

The vast majority of traffic violations brought before Leech Lake Tribal Court resulting in fines remain unpaid in the amount of \$271,825.28. This directly affects the operating costs for Tribal Court. And, in order to keep our communities safe, and bring those who disobey our tribal codes to justice, our Tribal Court depends on Band members paying their traffic fines. Without Band members paying their fines and holding themselves accountable, Tribal Court operating costs will be underfunded. Thus, the Leech Lake Band of Ojibwe will no longer be able to properly assert its tribal sovereignty in terms of a fully-functioning Tribal Court. The fines are used to pay for court and judicial staff along with a number of other very important programs that help keep our streets and Band members safe.

Leech Lake is considering different options in order to increase our Tribal Members' accountability in our Tribal Court system

- a. One option involves sending traffic case defaults to the Minnesota DMV. Then if there is non-payment in Tribal Court, judges may prompt the MNDMV to act on behalf of the court and suspend your MN driver's license. The driving offense may also go on your driving record which could cause your car insurance rates to increase.
- b. Option two involves deducting the traffic fine from any Band member's check who is employed by the Leech Lake Band of Ojibwe.

According to the Band's Traffic Code and Judicial Procedures Code, "any person issued a citation or summons to appear in the Leech Lake Tribal Court who fails to appear and/or fails to pay their fines shall be found in contempt of court." Tribal Court is authorized to do any or all of the following in order to enforce the penalties imposed:

- 1. Order the seizure and impoundment of the license plates of any vehicle driven or operated by a defendant at the time of the issuance of the fine
- 2. Order that the fine be reported to the Minnesota Department of Public Safety
- 3. Order the seizure and impoundment of **any vehicle** driven or operated by a defendant in the commission of the offense charged (the vehicle will be released upon payment of the fines)
- 4. Notify the Leech Lake Registrar of Motor Vehicles of the non-appearance or non-payment of fines and order that the amount due to be paid pursuant to the citation or judgment of the court be added to the fee charged for registration of any vehicle driven or operated in the commission of any offense or to any other vehicle the defendant seeks to register;
- 5. Issuance of a fine up to \$500.00; and/or
- 6. Issuance of a body warrant pending a hearing before the court.

Tribal sovereignty is of the Band's most important defining right and representative characteristic. Leech Lake has increased sovereignty and jurisdiction through the enactment of tribal codes and tribal court procedures as well as through federal mandate. Payment of these penalties is vital in enforcing our tribal laws and thus exercising our sovereignty.

The Band is considering enforcing all of the measures mentioned above which have been proven increasingly necessary in order to enforce Band members compliance. The Legal Department and the Tribal Court urge any individual with an outstanding fine to make arrangements to pay that outstanding amount as soon as possible. #### When will I get my payment?

On December 11, 2012, the Court filed an Order which directed the Claims Administrator to commence distribution of payments to the living members of the Historical Accounting Class no later than December 24, 2012. We commenced check distribution the week of December 17th, 2012.

As per the Court's Order filed on April 10, 2013, the Claims Administrator made initial determinations of eligibility for the Trust Administration Class on May 1, 2013. Additional deadlines have been established by this Court Order which will dictate the timeline for Trust Administration Class final determinations and payments:

- July 1, 2013 Written requests for reconsideration by a potential Class Member must have been postmarked and sent with supporting documentation to the Claims Administrator by July 1.
- August 1, 2013 The Claims Administrator responded to any requests for reconsideration with a second determination of eligibility.
- September 4, 2013 Written requests to appeal the second determination must be postmarked.

Distribution of Trust Administration Class payments will occur after the Trust Class eligibility appeals have been identified and resolved, and the Court has granted permission to disburse the funds.

Important Update: We have received many questions regarding when the Trust Administration checks will be mailed and the effect, if any, of the current government shutdown on those payments. The Special Master, the Honorable Richard Levie (ret.), is in the process of considering requests for reconsideration by those individuals whose claims for participation in the Trust Administration class were denied. We anticipate that process will be completed by the second week of December, 2013. Checks may then be mailed to class members upon court approval. It is our expectation that those checks will be mailed before the end of the year.

We are hopeful that the shutdown will not significantly delay the processing of payments. However, many of the personnel with whom we deal both at Interior and the Department of Justice who provide the claims administrator information to assist in the processing of claims have been furloughed. Therefore there is a possibility that if the shutdown continues for an extended period that the delivery of Trust Administration checks will be impacted.



### **LLBO Solid Waste: Recycling, Partnerships, and Rezcycle Days**

Tor the past 3 years, the team at Leech Lake Solid Waste has been making progress towards a more efficient and sustainable waste management department. The new Recycling Center, located at the main transfer station just south of Cass Lake, is close to being fully operational and is in the final stages of preparation. This is possible due to continued Tribal Government support, a grant from the US Department of Energy, and several smaller grants from the US Environmental Protection Agency, Minnesota Pollution Control Agency, Indian Health Service, and Cass County. The new center will enable Leech Lake Solid Waste to properly handle and manage waste material and recyclables, as well as providing a more efficient and safer way for the public/ community to dispose of these items.

A large part of the success is due to increased recycling by the Leech Lake community and its band members. Leech Lake Solid Waste has made it their priority to find markets, both locally and abroad, for materials that may or may not have been separated (sorted) previously. Most materials are disposed of at a cost. However, these markets allow for revenue generation when sourced properly. Other changes may seem common sense, but they have played an integral part in our success as well. An example would be: only handling absolute full loads, as opposed to maybe three-quarters or even half loads. Therefore, increasing the amount they are disposing of at one time, while decreasing the amount of trips to drop off sites known as MRF's (Material Recovery Facility's). These changes have reduced disposal fees by 75% just at the Cass County facility alone.

This success has not gone unnoticed, as several Tribes have been in contact for assistance over the past year. Most recently, they were asked by the Grand Portage Reservation to assist their Tribal Solid Waste in overall operation improvements. The purpose was to provide technical assistance related to identifying solutions for their growing transfer station facility. Grand Portage staff came to Leech Lake Solid Waste earlier in the year for assistance on how to begin the Integrated Solid Waste Management Plan, or ISWMP. This is a crucial step for Grand Portage as it provides the data and information required to seek out various funding. Once everybody was updated on the current status, Leech Lake Solid Waste provided solutions regarding the following to further assist the Tribe: How to address acquiring new solid waste contacts for their area, suggested additions or changes to policies, creation and collection of program fees, savings/revenue projections, data logs to track waste volumes, accounting functions pertaining to waste systems, understanding waste markets, how to identify capital investment needs, and other various solid waste criteria.

The team at Leech Lake Solid Waste makes every effort to provide a fun and inviting atmosphere with Rezycle games, raffles, and drawings for both young and old to participate in. People coming to the event are always encouraged to bring recyclables to drop off as well.

By continuing to reduce costs and educating the public regarding services in and around the community, the goals at Leech Lake Solid Waste are being accomplished one step at a time. These goals have provided Leech Lake Solid Waste the ability to generate revenue for the Tribe. This revenue goes directly into the General Fund, which increases and/or sustains the availability of funds provided for youth service, elder services, education, college scholarships, emergency medical services, and funeral assistance, just to name a few. Through continued support from the entire Reservation, Leech Lake Solid Waste staff is committed to caring about waste management for the betterment of the Leech Lake Band of Ojibwe, its members, and the surrounding community.

## **Economic Summit**

As Tribal leaders from Leech Lake, Red Lake and the White Earth nations met with politicians, industry executives and local business owners, the partial shutdown was simmering in the background, but did not distract from the importance of the summit.

From Fargo up to the Rainy River and over to Duluth; Leech Lake, Red Lake, and White Earth represent the largest regional economic concern in northern Minnesota that circulate hundreds of millions of dollars through this region annually. With mutual interests in several areas of the regional economy the three largest Bands in the state of Minnesota are pooling efforts in order to bring some of this clout to bear with regard to opportunity and prosperity.

The focus of the summit was Tribal purchasing and business ownership with additional sessions to bolster progressive environmental/economic opportunities such as sustainable foods and renewable energy, tracts that are growing with each passing year.

With the bountiful local wild rice harvest and tourism draw in such great supply discussions revolved around capitalizing upon the established market resources as well as the development of new cottage industries. Tax credits offered by the Treasury to local businesses for economic development in low-income areas across the United States and tax free bond investment were discussed as avenues of possible opportunity. However, nothing seemed to eclipse the need to concentrate on non-gaming revenue and the want for small business development and expansion with tax credits, income incentives and licensing fee reduction as part of unofficial talking points.

As this summit grows recurring themes of development and the need to move from the central revenue stream of gaming are starting to unearth the American Indian economic ethos. Diversification and innovation of local small business industry leaders seem to be on the constant horizon of the changing business landscape. There just needs to be a greater connection to opportunity, control of risk, and how business regulation(s) are implemented and prosperity propagated.


# Leech Lake Tribal College Forestry Program Begins

Imagine walking through a 50 year old red pine plantation estimating tree height and stand density, or walking the path around Leech Lake Tribal College, exploring the plants growing beneath the oak, pine and balsam canopy. Students in the new Forestry program (*Gikenimindwaa Mitigoog*), "getting to know the trees" can now earn a two year Associates in Science (A.S.) Degree in Forest Resources here in Cass Lake.

Hands-on field experiences and interaction with professionals from the LLBO Department of Resource Management, the U.S. Forest Service and Minnesota Department of Natural Resources are an important part of the program. Through a series of ten classes students learn field and GIS skills, study tree identification and forest management, explore ecology and wildlife biology and learn fifty woodland plants from small princess pine to towering white pines. In addition to the program requirements students are active in core liberal education courses such as Speaking Ojibwe, Introduction to Anishinaabe Studies, Ethnobiology and General Biology. Total credits to earn an A.S. in Forest Resources is 62 credit hours, typically four semesters spread over two years.

Each semester the program offers its two main introductory courses, Forest Resources 101, *Introduction to Forestry* and Forest Resources 120, *Natural Resources Careers*. These two courses provide students and anyone looking at a career in the forest, with a broad look at the field of Forestry, including ecology, tree identification, forest systems and management (FOR 101) and information on careers they might choose, presented by people currently working in the fields of forestry, research, fisheries, botany and wildlife.


