# **Our Stories Deserve to be Told**

Leech Lake and White Earth Nations collaborate with Bush Foundation to develop Native History Curriculumin Minnesota schools.

CASS LAKE – Education Director Laurie Harper, on behalf of The Leech Lake Band of Ojibwe of Ojibwe, announced, on January 7, a collaboration with the White Earth Nation and Bush Foundation to begin work on developing a Tribal History curriculum for the state. In 2023, bill S3019 "Native Histories and

In 2023, bill S3019 "Native Histories and Cultures Education Act of 2023" was signed into law. The bill focuses on requiring accurate, thorough education about Native people in Minnesota. Developing textbooks, maps, and gathering stories is what the \$7.7 million Bush Foundation grant award will help fund.

Involving Tribal youth in this effort—is a goal Harper has in moving forward.

"The history that is being taught in our classrooms-is from one point of view. A settler, colonial point of view. Our students deserve to help decide what they want other students in the state to know about their history and where we come from.

Our students having that power is a huge moment. They'll be able to learn about their own culture while contributing to this project. This is not going to be a small feat, often times it's going to be us going out of the way to make sure our stories are told, but it will be worth it," said Harper.

LLBO and White Earth Nation are beginning their approach to the project by strengthening Tribal and State relations and taking leadership roles in gathering data by harnessing the power of both Tribe's education offices. Vince Olson a drum keeper, and designated spokesperson for the White Earth Education department said preservation is a large goal of the project.

"Our stories are sitting around the table when we visit – when we go to dinner. It's important to take advantage of things around us to preserve these stories for our families and our future. We need to make it easy and accessible for teachers to be able to disseminate this information to our students, it's important. We need to be able to provide teachers with all the resources we can. It's not only important for our students but for nonnative students as well. If our neighbors don't understand who we are—we don't get treated any different," said Olson.

The Bush Foundation which plans to work directly with both Tribes in the development process said there is great potential for the state to become a Nationwide leader in education through this policy.

"We believe that investing in Native Nations and Native communities is one of the highest impact things we can do," said Bush Foundation Grantmaking officer, Mattie Harper DeCarlo.

# **LLBO and U.S. Forest Service Renew Previous Partnership to Safeguard Chippewa Natl. Forest**

The newly established agreement renews recently expired 2019 Partnership between U.S. Forest Service and Leech Lake Band of Ojibwe to Protect Cultural and Natural Resources

CASS LAKE - The U.S. Forest Service and the Leech Lake Band of Ojibwe signed a new memorandum of understanding for co-stewardship of the Chippewa National Forest.

The October 21 signing builds on an expired 2019 agreement and formalizes the consultation process

for forest management decisions. Leech Lake Chairman Faron Jackson Sr. said co-stewardship strengthens and supports the band's goals for environmental protection, economic growth, and preserving the tribe's way of life.

"Our ongoing partnership with the U.S. Forest Service reflects the deep connection the Leech Lake

Band has with the land," said Chairman Faron Jackson Sr. Together, we are committed to preserving our natural resources and cultural heritage, ensuring that our forests and waters remain healthy and abundant for future generations. Co-stewardship strengthens and supports the Band's goals for environmental protection, eco-

nomic growth, and, the preservation of our way of life. We look forward to continuing this important work, hand in hand, for the benefit of our people and the land we call home," Jackson said.

Today, about 90% of the reservation lies within forest boundaries while 45% of the forest lies within the reservation.

# LLBO Tribal Council and Cass County Hold Annual Meeting in Cass Lake

CASS LAKE – The Leech Lake Tribal Council held their yearly meeting with Cass County, Wednesday, January 17, 2024, at Cedar Lakes Casino.

The Tribal and city government used the time to review departmental standings and goals for 2024 in the following departments; judiciary, law enforcement, roads and trails, human services, environment, and legislative.

Tribal Chairman Faron Jackson who attended the meeting said he stayed thankful for the MOU between the two governments all 10 years it's been active—as it's only increased the effectiveness of the two entities.

"The possibilities are unlimited, everything we have here starts with truth and trust. This collective has brought more members to the table who have good ideas to face the hard challenges that affect our communities," said Jackson.

CASS LAKE – The Leech Lake Band of Ojibwe Reservation Business Committee (RBC) holds weekly briefings on Tuesdays, followed by RBC meetings on Thursdays.

All available council members, including scheduled presenters and LLBO division directors, attend RBC briefings. Agenda items are presented for discussion at the Tuesday briefings and then are voted on for passage at the Thursday meeting. Occasionally, due to time constraints, a combination briefing and conference will take place on the same day. One meeting was held within the last reporting month, January 1

One meeting was held within the last reporting month, January 1 to January 31. All RBC briefings and meetings are live streamed via Vimeo and are available to view on *leechlakenews.com* under "Videos." Official meeting minutes can also be found on *leechlakenews.com* under "LL Tribal Council" and "Tribal Council Meeting Minutes."

### **BRIEFING/MEETING RECAPS**

**1. January 16, 2025** A briefing & meeting was held in the RBC Government Chambers.

### **Presentations Given:**

- **Rebecca McConkey-Greene, Tribal Court** Presented the resolution 2025-43 Elder and vulnerable adult protection code. The protection code, which has been in the works for several years, was passed unanimously. It allows the courts to investigate reports and ensure the protection of elders and vulnerable adults.
- Following the investigation, services that may include a conservatorship or guardian appointment will be provided. The second part of the code allows the courts to investigate and further handle maltreatment findings.
- **Donovan Staples, Planning** Presented an idea he gave to all LICs regarding the potential moving and distribution of RBC salaries to LIC members. If enacted this idea would be included in the updated constitution. Constitutional reform is still ongoing.
- **Reuben St. Cyr, Housing** Presented a study that housing wants to conduct on homeless and displaced band members across the reservation. The data is to be shared with The United States Department of Housing and Urban Development (HUD) as this will help the Tribe get funding to address these issues.
- Michael Pegarsch, Tribal Development Presented a broadband construction agreement that will help keep the redesign of the community centers moving forward. This agreement includes fiber being added to the ground.
- Eric Devault, Public Works Presented a grant from the state of Minnesota for \$30,000 for the upkeep of roads.

Governmental Activities Chairman's Summary

#### Monthly Report

Boozhoo, my relatives, friends, community members and all! The Leech Lake RBC Tribal Council is moving forward on a solid agenda with Leech Lake priorities before the U.S. Congress. We are continuing to identify our critical needs. The Tribal Council members continue to work diligently in lobbying for unmet need dollars for the Leech Lake Band and its People. As we continue to move forward, we are all in this together, here is some of the news being reported to the great Leech Lake Nation.

Governor Walz Announces \$112 Million In Federal Funds to Keep Minnesota Homes Warm this Winter – On November 14, 2024 Chairman Jackson, Sr. wanted to announce a public service message that \$112 million federal funds had been awarded to the Minnesota Energy Assistance Program, admin-

istered by the MDC. Funding will provide energy assistance to incomeeligible Minnesota homeowners and renters to help keep their homes warm this winter. Chairman Jackson, Sr. had stated, "The Leech Lake Energy Assistance Program is critical in the cold winter months. The high heating bills and increased electric costs can become unaffordable for many of our families. The LLEAP is essential to helping our families stay warm. The additional federal funding is greatly appreciated for the Leech Lake Nation and Indian Country." If you have any questions about eligibility or about the Leech Lake Energy Assistance Program. Call (218) 335-3783 or toll-free at (866) 864-8668 to inquire about crisis help and emergency heating system repair or replacement.

Leech Lake Band of Oiibwe Awarded Circle of Excellence -On November 12, 2024 Chairman Jackson, Sr. had accepted the Circle of Excellence Award from the Minnesota Department of Human Services, Commissioner Jodi Harpstead. The working relationship between Leech Lake and the MN DHS has improved over the past two years. We have recently completed important work on a five-year umbrella contract with DHS. Leech Lake and DHS have been meeting in a consultation process to improve relations and create a better understanding of the human services needs with a new way forward. DHS Commissioner Harpstead had stated that her office is energized by its new partnerships with Leech Lake. Together, we created DHS's first five-year umbrella contract with a Tribal Nation. Chairman Jackson, Sr. had stated, "We know things that we deal with together can be kind of challenging at times, but we always prevail.

We've come to understanding how we can work through these impasses. We always need to keep the families in mind, especially, the programs and services that must address the social environment in our communities." Leech Lake is the first Tribal Nation in Minnesota to sign the fiveyear umbrella contract.

MCT, TEC Special Meeting -Announced on November 19, 2024, Chairman Jackson, Sr. will be attending the MCT, TEC Special Meeting at Hinckley on December 12, 2024. The purpose of the MCT, TEC Special Meeting will be the introduction of the new executive director and discussion on the enrollment amendment. Chairman Jackson, Sr. has stated for the record many times, "Leech Lake is an independent sovereign Nation that signed treaty(s) with United States. We have the inherent authority to exercise selfdetermination and determine our own Tribal membership criteria."

Leech Lake Duluth Fall Feast '24 – On November 16, 2024 Chairman Jackson, Sr. had attended the Leech Lake Band of Ojibwe

Duluth Fall Feast. The fall feast was planned by the Duluth Local Indian Council and community members. The event had a nice turnout of elders and Leech Lake members. A delicious meal was prepared for the attendees and the notable Oreo frybread. Gale's son had provided a wonderful hand drum song after the blessing. It was time to relax and visit past acquaintances, friends, and family. The Leech Lake Duluth Fall Feast has really grown over the years to a packed house. Chairman Jackson, Sr. had stated, "Duluth LIC members and community members did an outstanding job and Chi-Mii-Gwetch for the invite."

**It's Vaccinations Time** – Indian Health Services is providing the COVI-19 booster for the new strains. The flu shot vaccination is also available for the seasonal influenza. The Center for Disease Control (CDC) had stated, "Vaccines are the best way to protect yourself and your loved ones from preventable diseases. The vaccines you receive are safe. Vaccines may be required at work, school, for travel or more activities. Some vaccine-preventable diseases can have serious complications or even lead to later illness. Help protect yourself and other people you love by staying up to date on recommended vaccinations." Chairman Jackson and the First Lady received their Covid-19 and Flu shots last month. Vaccines can save lives. Please bundle up and dress warm when you go outside. Lots of elder's get pneumonia. Please take care of your health.

The Leech Lake Band of Ojibwe, RBC Tribal Council has been working with the Cass Lake I.H.S. Administration for years in fixing the Purchased and Referred Care Program. The Purchased and Referred Care Program is intended to provide specialty and emergency care for the Leech Lake Band patients when the services are unavailable at the Cass Lake I.H.S. Hospital, but bureaucratic issues and system underfunding undermine its effectiveness, leaving hundreds of our people with unexpected medical debt when it fails to pay the bills. In many cases, the report found, the problems stem from major issues within an I.H.S. program that refers patients to outside providers for medical care and then often doesn't pay the bill-leaving patients on the hook for debts that should not be their responsibility. After patients are sent to collections, »

the analysis notes, many are unaware they are carrying medical debt until it shows up on their credit report.

U.S. Vice President Harris Announces Final Rule Removing Medical Debt from All Credit Reports on January 7, 2025. U.S. Vice President Harris announced a final rule by the Consumer Financial Protection Bureau to remove medical debt from consumer credit reports. This rule will reduce the burden of medical debt and ensure that patients are not denied access to credit for home mortgages, car loans, or small business loans due to unpaid medical bills. More than 100 million Americans struggle with medical debt. Medical debt is the largest source of debt, \$49 billion in collections, making up a larger proportion of debt tradelines than credit cards, utilities, and auto loans. "No one should be denied economic opportunity because they got sick or experienced a medical emergency. That is why President Biden and I cancelled over \$1 billion in medical debt and cracking down on predatory debt collection tactics," said Vice President Harris.

The U.S. Congress Senate & House of Representatives Bills S. 3797 & H.R. 7516 – Purchases and Referred Care Improvement Act of 2024 is placed on the Union Calendar. The Bills will amend the

Indian Health Care Improvement Act to address liability for payment of charges or costs associated with provision of purchased/referred care services. This act may be cited as the Purchased and Referred Care Improvement Act of 2024. Updating authorities-Not later than 180 days of the enactment of this subsection and in consultation with Indian Tribes, the Secretary shall update applicable provisions of and exhibits to the Indian Health Manual, contracts with providers, and other relevant documents and administrative authorities to incorporate the provisions of this section. Chairman Jackson, Sr. – The Cass Lake Indian Health Service Purchased and Referred Care for life-threatening health care or referrals to see a specialist for chronic diseases has been on the Tribal Council's radar for some time. The Indian Health Service, a federally operated health care provider, was created in 1955 to help fulfill the federal government's trust responsibility to the Leech Lake Nation - legal and moral obligations to protect health care, which the Supreme Court affirmed. Another great concern of the Leech Lake People is the payer of last resort, meaning patients must exhaust all other options for payment before I.H.S. will cover services. U.S. President Biden has approved a rule that will reduce the burden of medical debt. The U.S. Congress has S. 3797 and H.R. 7516 have bills that will address liability for payment of charges or costs associated with a provision of purchased/referred care services. The Leech Lake RBC Tribal Council has lobbied and continues to educate the U.S. Congress on its Treaty obligations and the level of needed funding for the Leech Lake People's Health Care. We are seeing great movement by government leaders and attention by the press for Indian Health Care as it relates to one of our trust responsibilities.

Safety note: As the winter weather is moving into colder days. Furnace maintenance is a must for maximum air flow and energy efficiency. Changing the air filter will help with better air flow and protecting the furnace. Smoke and Carbon Monoxide detectors need annual maintenance with new batteries. Some detectors have a red button on the back of detector to see if it actually works or a red light on the front of the detector that shows it's on. In keeping our elders safe, check walk ways and stairs that are free from clothes and toys will prevent slips and falls. Pay special attention to small dogs and cats can also be obstacles for our elders. Removing the snow and ice will prevent slips and falls. Chairman Jackson, Sr. was the safety compliance representative for Xcel Energy before retirement. Please be safe and take care! Mii-Gwetch.

# Leech Lake Band of Ojibwe Tribal Police 2024 Illegal Drug Statistics

In 2023 Leech Lake Tribal Police Officers continued to work with the community to stop illegal drugs from coming to the Reservation. Below is an approximate number of drugs that were seized throughout the year by Officers.

#### Approximate total of seized drugs in 2023

Crystal Methamphetamine	229.02 grams
Fentanyl	147.62 grams
Powder Cocaine	27.76 grams
Gabapentin Prescription Pills	23.5 pills
Processed Marijuana	651.79 grams

Fourteen (14) arrests were made for drug charges with six (6) of those being adult males and eight (8) being adult females.

Leech Lake Tribal Police Officers seized five (5) firearms throughout the year.

Officers responded to thirty-one (31) overdoses consisting of both non-fatal and fatal. The approximate street value of the above listed drugs is \$45,747. \*Please note this is a rough estimate broken down to "Street Values" and that the prices on illegal drugs can fluctuate up or down on a daily basis depending on supply and demand in the local area.

# Northland Foundation Awards \$32,500 to Grantees in Support of Native Language, Traditional Activities, and Cultural Teachings

BEMIDJI – The Northland Foundation is providing \$32,500 in Maada'ookiing grants to 10 community members to strengthen Native culture.

Maada'ookiing ("the distribution" in Ojibwe) is a Native American-led program of the Northland Foundation. Grant funding up to \$5,000 is offered three times per year to Tribal citizens, descendants, or those who have kinship ties or affiliation to Native American communities within the foundation's geographic region. Maada'ookiing grants are considered and approved by the Maada'ookiing Advisory Board.

"This group of grantees is all about creating opportunities to engage in traditional practices, activities, and language learning. At the same time, they are nourishing cultural and community connections in beautiful ways," stated Cayla Bellanger DeGroat, Program Officer at the Northland Foundation.

"It is also a delight to have grantees who come from communities all across the region," she added, "The advisory board and foundation truly appreciate supporting the good work that is happening in many sites."

# Leech Lake Band of Ojibwe, January Quarterly Meeting

The Band recently held its Quarterly Meeting on January 17, the meeting was held at the S. Lake Community Center and broadcasted to Band Members online via livestream.

CASS LAKE – The Leech Lake Band of Ojibwe held their Quarterly Meeting in person Friday, January 17, 2025 at the S. Lake Community Center.

Chairman Faron Jackson Sr. gave the event's opening remarks and delivered the Chairman's report. Highlights from the Chairman's report and his goals for his upcoming term include; a wish to sign similar MOUs with Itasca and Beltrami County that have been signed with Cass County, addressing concerns with the IHS purchase and referred care(PRC) program. RBC has met with the IHS regional field director about community concerns as well as sending letters to the President and Congress about the lack of funding. Lastly, an update on the former palace casino/hotel, a portion of the building will be demolished to develop a medicalassisted detox center.

Jackson also promised to keep the Band updated on the new presidential administration's actions that will impact Tribal nations. Lenny Fineday, secretary-treasurer, who followed the chairman with a financial report echoed reassurance to band members that they will not let the band be affected

"We don't know what's going to happen but I want to assure every single band member that this Tribal Council is not going to sit back and just let cuts happen or let bad things happen to Indian Country. We are going to be out there advocating, letting our voice be heard, letting our position be known in the halls of Congress, with the new administration, and within inter-Tribal organizations as

well," said Fineday.

Several enrollment resolutions were passed at the meeting, including new enrollments, ineligible enrollments, and transfers to and from the band. New employees hired in the past quarter were also introduced and welcomed.

For those unable to attend in person, a livestream of the event is available on the official Leech Lake Vimeo and Facebook page. Full copies of the Chairman and Secretary-Treasurer reports can be found in the DeBahJimon newspaper.

Quarterly Meetings are held every three months on a rotating schedule between each reservation district. The next Quarterly Meeting will be held in April 2025.

- The Elder Christmas party was held December 9th, 2024,80 elders were in attendance.
- 107 families signed up for Toys for Tots.

### Child Welfare

- Additional funding is currently being sought, and two grant proposals were submitted.
   Additional funding will cover housing costs, clothing, and cultural and traditional teachings for staff and parents.
- A foster care specialist position will be added to urban offices to implement the process of licensing foster homes in the urban area, as there is currently a lack of placements for children.
- Partnering with UMD and Leech Lake Legal Services on a new policy and procedure for child welfare operations.

#### **Behavioral Health**

- LLBH Holistic Health practitioners provided a total of 186 reiki sessions to the Leech Lake community within the reporting period. Classes and Sessions are currently so popular that LLBH is looking to add an additional holistic health practitioner in the next quarter.
- LLBH held reiki training classes on December 11 and 12.
- LLBH made several herbbased products that were available to the community this past quarter including 23 tea blends, 9 different kinds of salves, and 64 essential rollers.
- LLBH sponsored the 3<sup>rd</sup> annual Leech Lake Men's gathering and traditional healing at Cedar Lakes. The event was

well attended.

• LLBH has begun publishing a monthly newsletter to highlight programs, staff and articles focused on community wellness.

- The Tribal Historic Preservation office assisted with a burial disturbance in Blackduck that took place in August 2024.

CASS LAKE – Leech Lake Tribal members helped combat the recent wildfires in California.

The series of several fires that burned across the northern half of the Golden State reached <95% containment the last week of January, after having killed at least 29 people, destroyed more than 15,000 structures, and put more than 80,000 people under evacuation orders. 12 firefighters from Leech Lakes

Gichigami firefighting module became one of several teams traveling cross country to offer support with containment. Several other tribal nations sent crews including; the San Manuel Band of Mission Indians and the Yurok Tribe from California, the Klamath Tribes in Oregon, the Navajo Nation, and Montana's Blackfeet Nation.

Leech Lake Chairman Faron Jackson, Sr., stated, "I just wanted to thank all of our firefighters from Leech Lake who went out to help the State of California with their wildfires. We all realize that this is an extremely hard and dangerous job. Leaving your families to help people in need, shows a commitment to protecting the citizens of California, our forest, and animals. Risking your life as a first responder shows dedication, sacrifice, and commitment to your job. I am very proud of all our firefighters. A job well done. I thank our creator for bringing all of our firefighters back home safely, aho."

# **Chippewa National Forest to** Thin Red Pines, Burn, and **Reseed Native Plants on Leech** Lake Reservation

BLACKDUCK - The Chippewa National Forest is seeking public comment on proposed timber harvest, prescribed fire and planting on 2,866 acres in the Blackduck Ranger District.

The activity is part of an Upper Mississippi — Ten Section Unique Area Biological Habitat Improvement Project within the boundary of the Leech Lake Reservation and includes areas along the Mississippi River between Lake Winnibigoshish and Cass Lake.

The project is meant to improve vegetative conditions to improve landscape resilience according to a 2024 agreement between the forest and the tribe. Forests diverse in

composition, structure and age may be more resilient and provide more diverse wildlife habitat conditions.

The forest plans to commercially thin about 269 acres of red pine plantations before burning roughly 1,500 acres to help restore native plant communities. Planting and seeding would also be done where needed.

# Zitkala-Ša, Native **American Activist,** Author, and Composer, to be Honored on **U.S. Quarter**

WASHINGTON - A Native American Rights Activist will be honored on a new US Mint quarter.

Zitkala-Ša, "Red Bird," Gertrude Simmons Bonnin: an activist, author, and composer who fought for citizenship and sovereignty

for Native Americans will be honored on a quarter as part of the Women American Quarters Program.

The American Women's Quarters Program celebrates the accomplishments and contributions

made by women of the United States with new quar-ters released by the U.S. Mint in partnership with the Smithsonian Museum.


Portraits of Zitkala-Ša from the Smithsonian's National Portrait Gallery and National Museum of American History were consulted for the design of the coin with the intent to (re)focus attention on giving her a rightful place in American women's history. The words "Author, Activist, Composer" were included in the design to amplify her role as a teacher, musician, and writer, and to consider the social and intellectual connections that fostered her success.

Zitkala-Ša (Bonnin) joined the Society of American Indians in 1907 and became co-editor of the American Indian Magazine.

Through her leadership in the Society of American Indians and respect across Indigenous communities, she influenced Congress towards the Indian Citizenship Act of 1924 and the Indian Reorganization Act of 1934. She also co-founded

the National Council of American Indians to advance voting rights, healthcare, legal status, and land rights, and she started the Indian Welfare Committee within the General Federation of Women's Clubs, expanding the recognition of the rights of Indigenous women more broadly in U.S. society.

In Late October 2024, the guarter featuring Zitkala-Ša was released into circulation.



# Native American Women Take Pride in Their Military Service

WASHINGTON – Native American women, like their male counterparts, share a proud tradition of military service.

During the Revolutionary War, Tyonajanegan, an Oneida, fought on the side of the United States with her husband during the Battle of Oriskany, Aug. 6, 1777, in New York. She died in 1824 at the age of 84.

The first active-duty Native American women were four Sioux nuns, serving as Army nurses during the Spanish-American War, in 1898. One of them died in Cuba from an illness and was buried with military honors.

During World War I, 14 Native American women were in the Army Nurse Corps.

Charlotte Édith Anderson Monture, a Mohawk from Ontario, Canada, graduated from nursing school in New York in 1914 and found work there. In April 1917, when the United States entered the war, she volunteered for the Army Nurse Corps.

In February 1918, she sailed to France where she treated wounded soldiers in the hospital and on the battlefield. After the war, she moved back to her reservation in Canada and continued her nursing practice there. In April 1996, she died at age 106.

About 800 Native American women served in uniform during World War II. Thousands of others who were civilians worked in factories on the home front producing arms for the war effort.

Marge Pascale, an Ojibwe, joined the Women's Auxiliary Air Corps, or WAAC, in 1943. "One thing about the service, you get two pair of shoes and you get a bed and you get to eat," she said, having experienced poverty.

Margie Williams, a Lakota Sioux, said during World War II, "It is with much pride that the Indian woman dons the uniform of her country to aid in settling the turmoil."

Ola Rexroat, an Oglala-Lakota, was the only Native American woman to serve in the Women Airforce Service Pilots during World War II. She flew AT-6 and PT-19 airplanes and towed targets for aerial gunners.

Following the war, Rexroat became an air traffic controller for the newly formed Air Force, making it a career. She also saw service during the Korean War.

Marine Corps Pvt. Minnie Spotted-Wolf enlisted in July 1943, becoming the first female Native American to join that service. In 1980, 60 Native American women were serving in the Alaska National Guard as Scouts, patrolling the west coast of Alaska. Terri Ann Hagen, an Army National Guard medic, was killed in 1994 while fighting a fire on Storm King Mountain in Colorado.

Many Native American women served in combat in Iraq and Afghanistan. Army Spc. Lori Piestewa, a Hopi, was killed in Iraq, March 23, 2003, when her convoy was ambushed. She was the first Native American female soldier killed in action on foreign soil. S-Peak, near Phoenix, Arizona, was renamed Piestewa Peak in her honor.

Today, Pfc. Jennifer Ruth Knowshisgun, an intelligence analyst at the 91<sup>st</sup> Engineer Battalion, 1st Armored Brigade Combat Team, from the northern Cheyenne and Crow Nations, said that her two years in the Army has helped her to develop leadership skills.

"The Army has given me more responsibilities," said Knowshisgun, speaking at Fort Hood, Texas, now named Fort Cavazos, Nov. 20, 2015. "I'm still a private, but I've gotten the chance to help out by getting the new soldiers situated into our unit."

# New Bipartisan Bill Empowers Tribal Nations to Combat Drug Trafficking and Protect Sovereignty

WASHINGTON- A new bill has been introduced to the US Senate floor focused on combating trafficking in Tribal communities.

The bill titled "Protection for Reservation Occupants Against Trafficking and Evasive Communications Today (PROTECT) Act " is to combat drug trafficking in tribal communities.

The PROTECT Act would expand the Special Tribal Criminal Jurisdiction (STCJ) program to allow tribal nations to prosecute non-Native offenders for drug crimes and gun crimes in furtherance of STCJ-covered crimes. The PROTECT Act would also allow tribal courts to execute warrants for electronic material to better combat drug traffickers and other criminals. The bill has bipartisan support and is sponsored by U.S. Senator Tina Smith (D-Minn.) and U.S. Senator Steve Daines (R-Mont.).

"For years, Tribal leaders in Minnesota have raised the alarm that drug traffickers are exploiting complex legal jurisdiction on Tribal land, making Native communities some of the most harmed by the opioid and fentanyl epidemics," said Senator Smith. "The PROTECT Act would help Tribes fight back against these drug traffickers. This proposal is bipartisan and common sense, and it respects and upholds Tribes' inherent sovereignty and right to protect their people."

"As deadly drugs like fentanyl and opioids flow across our open southern border, states like Montana are bearing the burden. Drug traffickers continue to exploit our tribal communities, so I'm proud to lead this bipartisan legislation to protect our Native American tribes and keep our communities safe, both in Montana and across the country," said Senator Daines.

For decades, drug traffickers have exploited the complexity of the criminal jurisdiction in Indian Country, which has contributed to American Indians and Alaska Natives being two and a half times more likely to become victims of violent crime and more likely to die of an overdose than other demographic groups.

The PROTECT Act would expand the STCJ program to allow tribal nations to prosecute non-Native offenders for drug crimes and gun crimes committed in furtherance of drug trafficking and other STCJ crimes. It would also grant tribal courts parity with state courts to execute warrants for electronic material and allow offenders prosecuted under STCJ to be incarcerated through the Bureau of Prisons Tribal Prisoner Program.

The opioid and fentanyl epidemic has touched every community in the United States, but nowhere is this crisis more acute than in Indian Country. For decades, drug traffickers have exploited the complexity of criminal jurisdiction in Indian Country, which has contributed to American Indians and Alaska Natives being:

2½ times more likely to become victims of violent crime than other demographic groups
More likely to die of an overdose than any other demographic group.

Complex criminal jurisdiction inhibits law enforcement response and causes many cases to go unprosecuted because unlike states and municipalities, Tribal Nations are not allowed to prosecute offenders for many drug crimes that occur on reservations. Tribal Nations need more authority to fight back against this crisis and defend their Nations.

The Protection for Reservation Occupants against Trafficking and Evasive Communications Today (PROTECT) Act would expand the successful Special Tribal Criminal Jurisdiction (STCJ) program to allow participating Tribal Nations to prosecute non-Native offenders for drug crimes and gun crimes committed in furtherance of drug trafficking and other STCJ crimes. More than 30 Tribal Nations currently use the Special Tribal Criminal Jurisdiction to prosecute non-Native perpetrators of domestic and sexual violence, human trafficking, stalking, and more. This highly successful program empowers Tribes to fight back against those who seek to exploit complex criminal jurisdiction and upholds Tribal sovereignty

The PROTECT Act would also grant Tribal courts parity with state courts to execute warrants for electronic material and allow offenders prosecuted under Special Tribal Criminal Jurisdiction to be incarcerated through the Bureau of Prisons Tribal Prisoner Program. Each of these reforms are essential to stopping drug traffickers from exploiting Tribal lands and communities.

# President Biden Grants Clemency for Leonard Peltier, 120 Tribal Leaders Petitioned Citing Justice and Human Rights

WASHINGTON- After nearly 50 years of incarceration, Leonard Peltier has been granted clemency.

Joe Biden, in one of his final acts as president, commuted the life sentence of Native American rights activist Leonard Peltier, who was convicted of two counts of firstdegree murder in the deaths of two Federal Bureau of Investigation (FBI) agents, on June 26, 1975, in a shooting on the Pine Ridge Indian Reservation in South Dakota. He was sentenced to two consecutive terms of life imprisonment and has been imprisoned since 1976.

The U.S. Parole Commission in July 2024, denied Peltier's last bid for release, which left his fate in the hands of Biden. Peltier has long maintained his innocence, and his commutation has drawn opposition from members of law enforcement.

Peltier, who is now 80 years old, has been imprisoned for almost five decades. He has been in declining health in recent years from diabetes, hypertension, partial blindness from a stroke, and bouts of Covid. The White House said the commutation would allow Peltier to serve the remainder of his sentence at home, "but will not pardon him for his underlying crimes."

In a public statement, Peltier expressed relief at being granted clemency.

"It's finally over — I'm going home," Peltier said. "I want to show the world I'm a good person with a good heart. I want to help the people, just like my grandmother taught me." Peltier's attorney also praised the outgoing president.

"President Biden took an enormous step toward healing and reconciliation with the Native American people in this country," said the attorney, Kevin Sharp. "It took nearly 50 years to acknowledge the injustice of Leonard Peltier's conviction and continued incarceration, but with the President's act of mercy Leonard can finally return to his reservation and live out his remaining days."

The push for Peltier to be released has been an uphill battle, going back several decades, human rights and faith leaders, including Pope Francis and the Dalai Lama, and Nobel Peace Prize recipients such as Nelson Mandela and Bishop Desmond Tutu,

have backed Peltier's release. Most recently, 120 Native Leaders across the country pleaded with former President Joe Biden to grant clemency to Peltier.

"Mr. President, we honor your demonstrated commitment to Indian Country. You have stood with us many times – both in the White House and in the U.S. Senate," reads their letter. "Our standing in the world as a champion of freedom, justice, and human rights cannot be maintained in a system that allows Leonard Peltier to die in prison" Notable signees of the letter include; 2 Leech Lake Band of Ojibwe RBC members, Chairman Faron Jackson sr., Secretary Treasurer Leonard Fineday, former RBC member LeRoy Staples-Fairbanks, Nick Tilsen, founder and CEO of NDN Collective, an Indigenous-led advocacy group; Mark Macarro, president of the National Congress of American Indians and Deborah Parker, executive director of the Native American Boarding School Coalition.

Activists with the American Indian Movement have lobbied for

Peltier's release since he was first imprisoned. AIM members, alongside the advocacy organization NDN Collective, walked from Minneapolis to DC as recently as 2022 to bring awareness to Peltier's case and his bid for clemency.

His conviction and sentence also inspired international support ranging from the human rights group Amnesty International to the United Nations Working Group on Arbitrary Detention. That advocacy increased in recent years as Peltier's health has worsened after spending more than half of his life behind bars.

"He's of old age and in poor health and he poses little threat to society. If there was ever a case that merited compassionate release, Leonard Peltier's is it," U.S. Sen. Brian Schatz (D-Hawaii) remarked from the floor of the U.S. Senate last month. "This is exactly what that awesome power is for. To right a historic wrong. And if not that, then just to show mercy and let an old man die with his family."

Schatz was one of more than two dozen members of Congress who wrote to Biden and urged him to "rectify this grave injustice that has long troubled human rights advocates and Native Peoples." The letter was signed by several prominent Minnesota Democrats including U.S. Sen. Tina Smith and U.S. Representatives Ilhan Omar and Betty McCollum. 10

# Tribal Nations Face Uncertainty as Federal Funding Freeze Creates Confusion Despite Court Orders

WASHINGTON – Within the first month of his presidency, Donald Trump issued several executive orders that impacted Indian country.

One of the most immediate impacts we have seen in Tribal offices has been with the funding freeze memo. The Trump administration's Office of Management and Budget (OMB) issued a memo freezing all Federal Grant and Loan programs on January 28, 2025.

The memo directs reviews by every agency to "align federal spending and action with the will of the American people as expressed through President Trump's priorities." The memo by acting director of OMB, Matthew Vaeth, also stated, "The use of Federal resources to advance Marxist equity, transgenderism, and green new deal social engineering policies is a waste of taxpayer dollars that does not improve the day-to-day lives of those we serve."

The memo was later rescinded, but federal agencies have continued to suspend funding, despite multiple court orders blocking the federal freeze.

#### LEECH LAKE BAND OF OJIBWE OFFICIAL STATEMENT

"The details of what this means for funding that is already authorized is unclear at this time. We have received limited correspondence from federal agencies regarding what this will mean for the Leech Lake Band of Ojibwe. We are attempting to communicate with as many federal agencies as we can to receive clarification but there are a lot of unknowns right now.

We recommend that all programs with federal funding remain in contact with their funding agency for further guidance. This is all of the information that we have at the moment but will update everyone as we learn more. All programs should continue operations as normal until more information is made available."

### FAQ

In implementing President Trump's Executive Orders, OMB issued guidance requesting that agencies temporarily pause, to the extent permitted by law, grant, loan or federal financial assistance programs that are implicated by the President's Executive Orders.

Any program not implicated by the President's Executive Orders is not subject to the pause.

# The Executive Orders listed in the guidance are:

- Protecting the American People Against Invasion
- Reevaluating and Realigning United States Foreign Aid
- Putting America First in International Environmental Agreements
- Unleashing American Energy
   Ending Dedication divertified
- Ending Radical and Wasteful

Government DEI Programs and Preferencing • Defending Women from

- Defending women from Gender Ideology Extremism and Restoring Biological Truth to the Federal Government
- Enforcing the Hyde Amendment
- Any program that provides direct benefits to individuals is not subject to the pause.

The guidance establishes a process for agencies to work with OMB to determine quickly whether any program is inconsistent with the President's Executive Orders. A pause could be as short as a day. OMB has worked with agencies and has already approved many programs to continue even before the pause has gone into effect. Any payment required by law to be paid will be paid without interruption or delay.

# Q: Is this a freeze on all Federal financial assistance?

A: No, the pause does not apply across the board. It is expressly limited to programs, projects, and activities implicated by the President's Executive Orders, such as ending DEI, the green new deal, and funding nongovernmental organizations that undermine the national interest.

Q: Is this a freeze on benefits to Americans like SNAP or student loans?

**A:** No, any program that provides direct benefits to Americans is explicitly excluded from the pause

and exempted from this review process. In addition to Social Security and Medicare, already explicitly excluded in the guidance, mandatory programs like Medicaid and SNAP will continue without pause.

Funds for small businesses, farmers, Pell grants, Head Start, rental assistance, and other similar programs will not be paused. If agencies are concerned that these programs may implicate the President's Executive Orders, should consult OMB to begin to unwind these objectionable policies without a pause in the payments.

#### Q: Is the pause of federal financial assistance an impoundment? A: No, it is not an impoundment under the Impoundment Control Act. It is a temporary pause to give agencies time to ensure that financial assistance conforms to the policies set out in the President's Executive Orders, to the extent permitted by law.

Temporary pauses are a necessary part of program implementation that have been ordered by past presidents to ensure that programs are being executed and funds spent by a new President's policies and do not constitute impoundments.

#### Q: Why was this pause necessary?

A: To act as faithful stewards of taxpayer money, new administrations must review federal programs to ensure that they are being executed by the law and the new President's policies.



Radioactive Waste Depository; the Governor's Task Force on Open Enrollment; the Chancellor's Council on Cultural Diversity, Minnesota State University System; the Special Education Advisory Council, State Board of Education; the Multi-Culture, Gender -Fair Task Force State Board of Education; and the Indian Advisory Councils for the University of Minnesota at Morris, Bemidji State University, and Bemidji Technical College." In February 2002, then President William J Clinton selected Joe to be part of the United States Great Lakes Fisheries Council to help protect and manage The Great Lakes from a Native perspective.

Joe's last job was working at the MN Department of Corrections to bring Native culture into the prison system in the correct way and to raise cultural awareness for prison officials and inmates. He retired in 2008.

Joe loved his kids Dax, Danielle, and Nicole so much and with Sherry instilled pride in who they are and a sense of service for community. However, his pride and joy were his two grandchildren, Joseph and Emma two special spirits that needed guidance. Joe was an amazing husband, father, grandfather, uncle, and a grandfather like presence for the many who needed him.

Joseph was preceded in death by his parents, Joseph and Alice (Bruce) Day; sisters, Josephine, Marlene, Carol, Maxine, and Betty; brothers, Clifford and Terry; plus numerous uncles, aunts, nephews, and nieces.


